## RATES UPDATE

The BC Utilities Commission issued a decision on February 15 regarding BC Hydro's rate application, which confirms an interim 3.91 per cent rate increase effective April 1, 2012. The decision also ordered an interim increase to BC Hydro's current rate rider of 2.5 per cent to 5 percent.
