

PROCUREMENT UPDATE

NOVEMBER 19, 2013

This update provides early information to the market about upcoming procurement opportunities. All contracts are subject to the Site C Clean Energy Project receiving environmental certification and other regulatory permits and approvals.

NEW PROJECT WEBSITE FEATURES BUSINESS AND JOB OPPORTUNITIES

The new Site C project website – www.sitecproject.com – features an enhanced Business and Job Opportunities page to provide information about current and upcoming business and job opportunities. People interested in participating in the project are encouraged to check this website for updates and current project information.

By way of update, procurement for the Main Civil Works and Worker Accommodation contracts is expected to commence in spring 2014.

The **Main Civil Works** is expected to be the largest contract opportunity of the Site C project, and includes construction of the earthfill dam, the roller-compacted concrete buttress and the diversion tunnels, as well as excavation and bank stabilization activities. Further information about the procurement process for this contract is available on the website.

The **Worker Accommodation and Site Services** contract will include the design, fabrication, installation, partial financing and servicing of two temporary accommodations, one located on the north bank and one on the south bank of the Peace River. Further information about the procurement process for this contract will be posted on the website later this year.

UPCOMING SITE C PUBLIC HEARINGS – REGISTER BY NOVEMBER 25

The Joint Review Panel reviewing the proposed Site C Clean Energy Project has announced the process for public hearings. The preliminary schedule has an opening session in Fort St. John on December 9, 2013, with hearings completed in January 2014.

You are encouraged to make your voice heard by making a presentation or a written submission to the Joint Review Panel.

Registration to present, and written submissions must be submitted to the Panel by **November 25, 2013**.
