

SCHEDULE "B"

FORM OF UTILITY LICENCE
SITE SPECIFIC TENURE

This Utility Licence is a "Site Specific Tenure" within the meaning of the Master Agreement dated August 1, 2014 between Her Majesty the Queen in Right of the Province of British Columbia and British Columbia Hydro and Power Authority as may be amended by subsequent agreement in writing between the parties from time to time (the "Master Agreement") and is governed by the terms and conditions of the Master Agreement.

This Site Specific Tenure is dated for reference October 11, 2018 and is made under the *Land Act*.


1. LAND: "**Land**" means that part or those parts of the Crown land either described in, or shown outlined in bold or red line on, the schedule attached to this Site Specific Tenure entitled "Legal Description Schedule", except for (i) those parts of the land that, on the Commencement Date, consist of highways (as defined in the *Transportation Act*), and (ii) land covered by water.
2. PURPOSE: This Site Specific Tenure is for the purposes of:
 - (a) excavating for, constructing, erecting, stringing, or otherwise installing, operating, maintaining, inspecting, repairing, altering, removing or replacing the Improvements necessary for the distribution and transmission of electric energy and for the telecommunications related to BC Hydro's distribution and transmission of electric energy; and
 - (b) grounding any Improvements or other objects on the Land when in BC Hydro's opinion such grounding is necessary to reduce a public hazard
3. TERM: From October 11, 2018 (the "**Commencement Date**") and terminates on the 8th anniversary of that date (the "**Term**").
4. FEE: "**Fee**" means \$3,915.00 for the Term, the receipt of which the Province acknowledges.
5. NOTICE: Any notice required to be given to the Province shall be sent by prepaid mail or delivered to:

6. SPECIAL TERMS AND CONDITIONS: Special Terms and Conditions attached form a part of this Site Specific Tenure.


